

It is also widely accepted that any failure to identify ground issues often results in **unforeseen costs to the project**, as well as that all too familiar issue of **late completions**. However, what is often overlooked is SI's ability to actually save money, as any subsequent ground engineering work, such as **piling**, can be effectively matched to the ground conditions and not guessed at or 'over engineered' to simply avoid unknown future issues.
